GENERAL The General Manager reported that the inaugural train service for the newly completed line through the San Gabriel Trench will take place Monday, July

24, and distributed an invitation to the event.

The General Manager reported that tests revealed that water from Well No. 16 has high fluoride and arsenic levels. In an effort to reduce the levels, staff will be lowering the flow rate (GPM). If that is not successful, the District can purchase water at a reduced rate from Sunnyslope, and/or have the well profiled to see if the fluoride is coming into the well at a particular area that can be patched to prevent intrusion.

The General Manager reported that the blending paln for Well No. 11 has been sent out to bid, and he should have results of the solicitation at the next meeting.

Consideration of award of contract for Well No. 11 blending plan.

DIRECTOR COMMENTS

Director Cammarano inquired into how Wellington Love is doing. Nobody present had information.

Director Cici inquired as to whether credit card statements are disclosable under the Public Records Act. District Counsel advised that when public money is being spent, the public has a right to know the details, but that certain information may be redacted from the records for privacy and security reasons.

Director Chan inquired as to traffic cones outside the District office, and was informed that they belonged to Walsh, who was currently performing work in the street.

Director Chan reported that he had attended a public outreach workshop concerning the future use of the San Gabriel Nursery, and found it informative.
