MINUTES OF A REGULAR MEETING OF THE BOARD OF DIRECTORS OF SAN GABRIEL COUNTY WATER DISTRICT HELD ON AUGUST 10, 2021

CALL TO ORDER

A regular meeting of the Board of Directors of the San Gabriel County Water District was called to order on Tuesday, August 10, 2021, at 8366 Grand Avenue, Rosemead, California at the hour of 4:05 p.m., available to the public via teleconference.

ROLL CALL

The Board of Directors of the San Gabriel County Water District convened a regular meeting on August 10, 2021. Present at the District office were General Manager Jim Prior, Carmen Corona, Casey Feilen, Directors Taylor, Cammarano, DeLaTorre and Chan and District Counsel Koczanowicz. Present on the phone was Director CiCi and Director Chavez

from Upper District.

AGENDA

Upon motion by Director DeLaTorre and seconded by Director Chan, the Board voted to adopt the agenda as presented; passed 5 - 0.

PUBLIC COMMENT Cookie Cici attended via phone and extended her best wishes to everyone at the District.

MINUTES

Upon motion by Director Chan and seconded by Director Cammarano, the Board voted to approve the minutes for a regular meeting of the Board of Directors held on July 27, 2021. Motion passed 5-0.

DEMANDS

Director DeLaTorre motioned to authorize an electronic funds transfer in the amount of \$21,173.04 from the general account to the revolving account and approval of invoices for the General Account in the amount of \$365,365.62. The motion was seconded by Director Cammarano. Director Chan and Director Cammarano had some questions regarding specific entries, which were answered by staff. The motion to approve passed 5-0.

DISTRICT COUNSEL REPORT District Counsel reported on positive outcome of negotiations with City of Rosemead regarding Encroachment Permit and other related fees, that the City was attempting to charge the District.

ACTION

MISC INFORMATION

The Board received and filed the July Water Well Report.

GENERAL MANAGER COMMENTS The General Manager reported that Well#15 is back on line with a rebuilt motor and working properly; that mid-year budget review will be presented to the Board at the next meeting which will start at 3:00 pm to afford more

time for the item; that Jim Prior and Casey Feilen met with Upper San Gabriel Valley MWD to start discussions on scheduling a "state of the water" meeting which would include the District and other water providers in the area; that District received a copy of a letter sent to the San Gabriel Mayor and City Council by Daniel Bryant (copy was distributed to the Directors); staff is having discussions to consider potential connection to Metropolitan Water District to provide back-up water supply in the event of need with initial estimated costs of \$3M(connection and transmission pipeline) and an estimated time period of 2 years with this item coming to the Board for consideration in the future once the discussions result in more concrete information; that District received a call from a customer requesting that her smart meter be replaced with a regular meter due to health concerns. Staff will investigate.

FUTURE AGENDA ITEMS As reported the Board will have a mid-year budget review on at the second meeting in August.

DIRECTOR COMMENTS

Director Cammarano liked the letter written by Daniel Bryant; Director Chan inquired if staff was doing well.

ADJOURNMENT

Upon motion by Director Taylor and seconded by Director Cammarano the Board voted unanimously to adjourn the meeting at 4:34 p.m.
