MINUTES OF A REGULAR MEETING OF THE BOARD OF DIRECTORS OF SAN GABRIEL COUNTY WATER DISTRICT HELD ON JANUARY 8, 2019

CALL TO ORDER

A regular meeting of the Board of Directors of the San Gabriel County Water District was held on Tuesday, January 8, 2019, at 8366 Grand Avenue, Rosemead, California at the hour of 4:00 p.m.

ROLL CALL

President Taylor; Directors Cammarano, Chan, Cici, and DeLaTorre; General Manager Prior; Assistant General Manager Feilen; and District Counsel Colin O'Neill were present.

AGENDA

Upon motion by Director DeLaTorre, and seconded by Director Cici, the Board voted unanimously to adopt the agenda for this regular meeting of the Board of Directors held on January 8, 2019.

PUBLIC COMMENT Ms. Cici reported that the annual San Gabriel Women's Foundation holiday luncheon was a great success and that she was pleased to see staff in attendance.

Sean Harkness, of C.V. Strategies, was in attendance and wanted to introduce himself to the Board, as he would be assuming a larger role on the District's account.

Kevin Smead, of Stetson Engineering, gave a presentation regarding water availability assessments, along with background and the current state of the Main San Gabriel Basin.

MINUTES

Upon motion by Director Chan, and seconded by Director DeLaTorre, the Board voted unanimously to approve the minutes of the regular meeting of the Board of Directors held on December 11, 2018.

DEMANDS

Upon motion by Director Chan, and seconded by Director Cammarano, the Board voted unanimously to approve the payment of check numbers 19892 through 19944 from the General Account in the aggregate amount of \$379,902.39, and check numbers 11722 through 11753 from the Revolving Account in the aggregate amount of \$19,537.04, for the December, 2018 invoices.

DISTRICT COUNSEL None.

ACTION

Upon motion by Director Cammarano, and seconded by Director Chan, the Board voted unanimously to approve the lease of 250 acre-feet of production rights from La Puente Valley County Water District at a discounted rate of \$758.94 a/f, for a total amount of \$189,735.00, representing a savings of \$18,765.00.

Upon motion by Director Chan, and seconded by Director Cammarano, the Board voted unanimously to approve the purchase of three work trucks for a total amount of \$86,744.29.

INFORMATION

The December, 2018 Banking and Investment Report was received and filed.

GENERAL MANAGER COMMENTS

The General Manager reported that the new Cassell software implementation was underway.

The General Manager inquired if any directors wished to attend the Washington D.C. ACWA conference. Little interest was expressed, but directors did express an interest in the May ACWA conference in Monterey.

The General Manager provided a handout and agenda for the annual AGWA conference in February for the directors' consideration.

The General Manager reported that the Emergency Preparedness Coordinator had planned a webinar on safety solutions and training. Director Taylor added that at some point in the future he would like a presentation from the Emergency Preparedness Coordinator.

The General Manager reported that staff was in the process of establishing the total San Gabriel tax amounts paid to date by non-residents.
