DISTRICT District Counsel provided a briefing on a recent decision from 9th Circuit, (Shyler v. 13PCH) wherein the Court of Appeals upheld Trial Court's COUNSEL REPORT

decision greatly reducing the requested attorney's fees to an ADA premises violations serial litigant firm. Court found the requested \$35K grossly excessive in view of the routine template formulaic work and allowed only

\$7,896.
